CUSTOMS POWER OF ATTORNEY
ORIGINAL BILL OF LADING FOR OCEAN SHIPMENT OR AIRLINE AIRWAY BILL
*NOTE * NAME ON ABOVE DOCUMENTS SHOULD MATCH*
CONSIGNEE: SHOULD BE OWNER OF VEHICLE
NOTIFY PARTY: SHOULD BE G&K AND CUSTOMS BROKER
LIST ANY OTHER CONTENTS IN VEHICLE OR TRUNK ON BILL OF LADING

BONDING AND CLEARING CHARGES:

BONDING PREMIUM 3% OF VALUE SHOWN ON BILL OF SALE (250.00 MINIMUM)
BOND APPLICATION FEE \$250.00
BOND RELEASE FEE \$153.15 OR CURRENT RATE
ICI LAB PROCESSING FEE 1 % OF VALUE
DOT/EPA WARRANTY FEES (AS APPLICABLE) \$350.00 EACH
TRUCKING CHARGES FROM LONG BEACH TO G&K \$225.00 TO \$500.00 DEPENDING ON VEHICLE TYPE
TRUCKING CHARGES FROM PORT HUENEME TO G&K \$225.00 TO \$500.00 DEPENDING ON VEHICLE TYPE

FREIGHT/DOCK HANDLING AND/OR ANY STORAGE CHARGES
DOT PETITION FEES MAY APPLY TO CERTAIN MODELS.

PLEASE NOTE –

CUSTOMS MAY REQUIRE YOUR VEHICLE TO BE PHYSICALLY EXAMINED. VEHICLES WHICH REQUIRE EXAM ARE SUBJECT TO ADDITIONAL COSTS INCURRED IN MOVING VEHICLE TO EXAM SITE AND BROKERS/WAREHOUSE FEES FOR HANDLING EXAM. ALSO, VEHICLES SHIPPED IN CONTAINERS INCUR ADDITIONAL CHARGES FOR MOVING AND DEVANNING CONTAINERIZED SHIPMENTS. ALL DOCUMENTS SHOULD BE FORWARDED TO EITHER G&K OR THE CUSTOM BROKER. CHARGES FOR BONDING AND CLEARING ARE PAYABLE UPON PRESENTATION OF INVOICE.

CHARGES FOR CONVERSION ARE PAYABLE UPON COMPLETION OF CONVERSION (PARTIAL DEPOSIT WILL BE REQUIRED). FINAL PAYMENT MUST BE IN THE FORM OF CASH, CASHIERS CHECK, OR WIRE TRANSFER ONLY. ANY PAYMENTS IN THE FORM OF PERSONAL OR COMPANY CHECK ARE SUBJECT TO PAYMENT BY CUSTOMER'S BANK PRIOR TO RELEASING THE VEHICLE. ALL PRICES ARE SUBJECT TO CHANGE WITHOUT NOTICE.
